1. Background

- a) Vivekananda Vidyavardhaka Sangha Puttur ® formerly known as The Puttur Education Society having registered office at Neharu Nagara, Puttur D K 574203 formed pursuant to Act XXI of the Governor General of India in Council entitled An Act for the Registration of Literacy Scientific and Charitable Societies 1860, vide registration number 02/1915-16 on 23rd December 1915 by Assistant Registrar of Companies. As per change in law, the Society, registered with Registrar of Societies Mangalore vide registration number DKM-S2-1915-16 on 23rd December 1915 under Karnataka Societies Registration Act, 1960
- b) The Society has been granted registration under section 11 of the Foreign Contribution (Regulation) Act, 2010 vide Registration No. 094630158 and valid upto 31-03-2029

2. Basis of Accounting

- a) The FCRA accounts have been drawn under historical cost convention in accordance with the generally accepted accounting principles and on cash basis.
- b) **Preparation of Financial Statements**
The Financial Statements of the Society are prepared in consonance with the Technical Guidance provided by The Institute of Chartered Accountants of India and the form and content of the Balance Sheet and Income and Expenditure Statement has been drawn to fall in line with the recommended form and content.
- c) **Use of Estimates**
The preparation of the financial statements in conformity with generally accepted accounting principles required the management to make estimates and assumptions to arrive at the reported amounts of assets and liabilities (including contingent liabilities) and the reported income and expenses during the year The management believes that, the estimates used in preparation of financial statements are prudent and reasonable.
- d) **Income Recognition**
 - i) **Donations and Contributions**
Foreign Contributions received in foreign currency are accounted based on the amounts received and credited by the bank.
